KLT organizes hikes, paddles, an annual March lecture (Lyceum) series, and outdoor photography and painting

Stewardship - KLT staff and board members oversee the management of KLT's fee lands, monitor conservation easements and work with 50 volunteer stewards. KLT's stewards collectively volunteer over 1,000 hours each year for trail maintenance, monitoring, and public access projects. Conservation parcels that are especially large in acreage, or have unique or complex management needs, have more than one volunteer steward. KLT's Board of Directors has developed a Strategic Conservation Plan that focuses on ten priority conservation values. KLT's Strategic Conservation Plan was developed with GIS based natural resource information, and with information from community open space and comprehensive plans. This plan will inform and guide KLT's land

Land Protection - Since 1988, KLT has worked cooperatively with landowners and communities to conserve our region's natural assets. KLT has conserved 4,000 acres in a service area that covers 412,000 acres and 21 towns primarily in Kennebec County, but also in Androscoggin and Franklin counties. KLT holds conservation easements on, accepts gifts of, and purchases significant lands to further the mission of the organization.
