HALES POND WOODLAND PRESERVE DONATED TO KLT

It's fitting that as we begin our year-long 35th-anniversary celebration, we are recognizing Albert Ferguson and his wife, Effie, and John Moore's companion Marilyn Donnelly for their donation of the Hales Pond Woodland Preserve. This 74-acre, topographically varied property in Fayette features 2,700 feet of undeveloped stream and pond frontage, vernal pools, and biologically rich woodland and wetland habitats. Remote Hales Pond, with a maximum depth of 50 feet and an average depth of 14 feet, supports a warm water fishery and a diversity of emergent and aquatic plant species. The Maine Department of Inland Fisheries and Wildlife has mapped the wetlands and waters of Hales Pond as ecologically valuable Inland Waterfowl and Wading Bird Habitat.

Albert and John purchased this beautiful property sixty-two years ago, and with this donation to KLT they have ensured that this land will forever benefit nature and people.*

KLT will manage Hales Pond Woodland Preserve to protect wildlife habitat and water quality and for low-impact outdoor recreation, including hiking, snowshoeing, hunting, nature observation, paddling, and fishing. In 2023 we will build a trail and a parking area on Bamford Pond Road in order to provide public access to the property. We hope you will be able to join us for our late summer property and trail dedication.

Thank you for your continued support of our work to conserve important lands; provide public access for hiking, paddling, skiing, blueberry picking, and hunting; and promote land stewardship, conservation education, and partnerships.

Oak Hill Conservation Area Property Dedication

On August 18, over 65 people of all ages joined KLT for an inspiring land dedication at the 134-acre Oak Hill Conservation Area in Fayette. After wonderful comments from KLT president Janet Sawyer and Ron Hewett, we walked on the recently built Sedge Ridge Loop Trail to a scenic viewpoint overlooking Echo Lake. As we walked, the Hewett family reminisced about growing up exploring the property, sharing stories of hours spent collecting sap for sugaring, hanging out on the ledges, and snowmobiling in the winter.

Ron Hewett originally approached KLT in March of 2021 about protecting his family's land. His parents, Jean E. (Wheeler) Hewett and the late Walter F. Hewett, had owned the property since 1965. KLT purchased the 120-acre property from the Hewett family in December of 2021 with the support of a major anonymous donor as well as the Davis Conservation Foundation, the Maine Community Foundation,



area lake associations, and many other generous donors. In 2022 we purchased an additional 14-acre parcel along Hales Brook and added this ecologically important parcel to the Oak Hill Conservation Area. Thank you, Hewett family, Terry and Michele Briggs, and James Dwyer.

The new conservation area features conifer and hardwood woodlands, wetlands along Hales Brook, and a four-acre field. Located on the northern portion of Oak Hill between KLT's Surry Hill and Baldwin Hill conservation lands, it overlooks Echo Lake to the east and the western mountains of Maine and into New Hampshire to the west.

Thank you to our 2022 interns, our stewardship team, the Maine Conservation Corps, and our team of community volunteers, all of whom worked hard on the trail over the summer. Thanks as well to everyone who joined us to celebrate the conservation of this property. If you haven't done so already, we invite you to walk on the new mile-long loop trail that traverses nineteenth century stone walls and exposed ledge to reach a scenic viewpoint with a high point of 680 feet.

Earlier this year, conservation-minded landowners presented KLT with an opportunity to purchase a seven-acre parcel adjacent to Nancy's Bog. Because it provides a key connection for future trails and protects important wetlands and upland forest, acquisition of this valuable property has long been a priority for KLT. We took a leap of faith and purchased this land as soon as it became available, knowing that our donors would support the decision.
